Dear friends,

Financial highlights of the Year 2004/2005

- 1. We have re-launched a life membership drive in the current year (2004/2005) and have seen several members expressing their interest in becoming members. Already four new life members have joined us and fifteen annual members have paid their subscription. Money collected towards the membership subscription in this year amounts to \$450
- 2. We have decided to keep the life membership fees in a fixed deposit account in order to hold this as a reserve not available for appropriation and to get a reasonable return on the investment. We have opened a fixed deposit account at St George bank and transferred \$5,000 in September 2004. This is yielding an interest of 5% per annum. The return is sufficient to meet the monthly running expenses such as postage and stationary.
- 3. Eight boxes of books have been sent to Hartley College Library. A shipping charge of \$160 was incurred. Our secretary Paskarajothy managed to negotiate a concessionary deal as it is a school project.

(Unanimously Adopted at the Special General Meeting held on 10 July 2004)

1. Name

The name of the Association shall be Hartley College (Point Pedro, Sri Lanka) Past Pupils Association, NSW Branch.

2. Aims & Objectives

- a) To foster and maintain fellowship amongst the past pupils of Hartley College, Point Pedro, Sri Lanka.
- b) To assist students at Hartley College, Point Pedro in maintaining and improving the standards set in the past.
- c) To maintain links with present College authorities and students and obtain information on the requirements of financial assistance required for the development of the College.
- d) To raise funds through donations from it's members and well-wishers, organised concerts and cultural functions, and other activities for the purpose of meeting the aims and objectives stated in articles 2b, and 2e.
- e) To provide financial and material assistance to build, rebuild, renovate, expand or set-up, I) library, ii) classrooms, iii) science, language and computer laboratories, iv) woodwork, metal work, and handicraft workshops and v) sports and recreational facilities at Hartley College, Point Pedro.
- f) To maintain links with similar Associations of Past Pupils of Hartley College in other parts of the world.
- g) To associate with other organisations of past pupils of Colleges of Sri Lanka, with similar objectives, based in Sydney.
- h) Generally, to do, to engage in and execute all such other acts, deeds or things as are or may be necessary for or incidental or conducive to the attainment of the objectives of the Association.

3. Membership & Subscriptions

- a) Membership shall be open to all past students, teachers and non-tutorial staff of Hartley College now resident in NSW and ACT <u>and also resident in other states of</u> <u>Australia who do not have access to join as a member of a HCPPA in the state</u> where he/she resides.
- b) Categories of Members and Membership Fees
 - <u>Ordinary Members</u> The annual subscription for ordinary members shall be \$10.00 per member and this sum may be increased or decreased from time to time by the Committee of Management.
 - (ii) <u>Life Members</u> The life membership shall be \$100.00 per person and this sum may be increased or decreased from time to time by the Committee of Management.
- 4. Committee of Management

(i)

- a) The affairs of the Association shall be managed by the Committee of Management.
- b) The Committee of Management shall consist of a President, Vice President, Honourable Secretary, Treasurer, Social Secretary and two (2) Committee members, all of whom shall be members of the Association.
- c) The Committee of Management shall be elected at the Annual General Meeting and shall hold office until the next Annual General Meeting.

- d) No member of the management committee shall be appointed to any salaried office of the organisation or any office of the organisation paid by fees, and no remuneration or other benefit in money or money's worth shall be given by the organisation to any member of the management committee; except payment of out-of-pocket expenses, interest at a rate not exceeding interest at the rate for the time being charged by the bankers in Sydney for money lent to the organisation and reasonable and proper rent for premises let to the organisation.
- e) In the event of death or resignation of an elected committee member, the committee of management may nominate a current member of the association to carry out the functions until a new committee member is elected by the association. At any time the number of such nominated committee member shall not exceed two.
- 5. (a) Patron

The Principal of the College shall ex-officio be the Patron of the Association.

(b) Vice Patron

The Association shall have minimum two (2) and maximum five (5). Vice Patrons. The management committee shall select them from the life members. They will hold office for five (5) years. They are entitled to attend the management committee meetings as advisers / observers only and shall have no voting rights at the meetings. In the event of physical incapacity, death, resignation or expiry of the term of five (5) years, the management committee shall appoint another life member of the Association or reappoint the same member for a further period of five (5) years.

6. Auditor

An auditor shall be appointed at the Annual General Meeting to audit and report on the accounts of the Association and shall hold office until the next Annual General Meeting.

- 7. Meetings
 - a) Meetings of the Association and the Committee of Management shall be convened by the Secretary or by the President as and when found necessary. Three weeks notice shall be given to all members.
 - b) The Annual General Meeting shall be held in the second weekend in February of each year or as early as possible thereafter.
 - c) Special General Meetings shall be convened by the Secretary on a requisition signed by one third (1/3) the number of members on roll or 15, whichever is less.
 - d) The quorum for all meetings shall be one third (1/3) the number of members on roll or 15, whichever is less.
 - e) The Agenda for the AGM shall include:
 - (i) Presentation of minutes of the previous AGM.
 - (ii) Presentation of the Annual Report of the Committee of Management and the annual audited statement of accounts for the year ending January of the year.
 - (iii) Election of a Committee of Management.
 - (iv) Election of an Auditor.
 - (v) Any other business of which due notice has been given to the Secretary.
- 8. Funds
 - a) Funds of the Association shall be maintained in two accounts namely "Hartley College Past Pupils Association, NSW Branch" and "Hartley College Development Fund" with a recognised financial institution as found appropriate by the Committee of Management. The Treasurer shall be responsible for maintaining these accounts of the Association.
 - b) The funds of the Association shall be derived from subscriptions, donations and such other sources as the Committee of Management determines and in a manner not inconsistent with the objectives of the Association.

- c) The funds derived from subscriptions (membership fee) shall be maintained in the "Hartley College Past Pupils Association, NSW Branch" account and shall be used for the day to day running of the Association.
- d) The funds derived from donations and other sources as the Committee of Management determines shall be maintained in the "Hartley College Development Fund" account and shall be used for the development of Hartley College, Point Pedro, Sri Lanka.
- e) The funds of the Association shall be applied only for the promotion of the objectives of the Association.
- f) The funds shall not be paid to or distributed amongst present or past members of the Association under any circumstances.
- 9. Amendments to the Constitution
 - a) Amendment to the constitution shall be considered only when presented as a resolution at an Annual General Meeting or a Special General Meeting at which at least two fifths (2/5) of the members on roll are present and passed by a majority of at least two thirds (2/3) of members voting for the resolution.
 - b) If the required two fifths (2/5) of members on roll are not present at the meeting where the resolution for amendment to the Constitution is presented, the resolution shall be reconsidered at an adjourned meeting specially convened for the purpose. At the reconvened meeting, the stipulation regarding the presence of two fifths (2/5) of members on roll shall not operate.
 - c) The minister of the crown for the time being administering the Charitable Collections Act, 1934 shall be notified of the amendment and such amendment shall not be effective unless the minister has signified his/her approval to such amendment being made.
- 10. Dissolution
 - a) In the event of dissolution, the surplus assets of the Association shall be credited to the benefit of Hartley College, Point Pedro or to an approved charity that is a registered or exempt charity.
 - b) The Association can only be wound up by three fourths (3/4) of the members on roll deciding to do so at a Special General Meeting.

1. CHAIRMAN 'S WELCOME ADDRESS

He thanked all the committee members and their families for having worked on the PPAs activities during this year. He paid special tributes to late Mr Balakrishnan. 5. AUDITOR

The floor unanimously elected Mr. P.Arunodayam as the auditor for the next financial year. Proposed by K. Kaneshalingam and seconded by Mr V. Sundaravel

6. PROPOSED AMENDMENTS TO THE CONSTITUTION

EXTENDING MEMBERSHIP TO HARLEYITES LIVING IN AUSTRALIA BUT VICTORIA

It was resolved to amend the constitution to extend membership to Hartleyites living in Australia but away from Victoria. Mr Elango explained the proposal. Dr. V. Vasanthakumar stated that a similar works in Canada and America.

Mr. C. Paheerathan asked whether there would be difficulties in communication. Mr Elango explained that they will be included in the mailing list and wher ever possible in email. The amendment was adopted. Proposed by Mr Elango and seconded by Mr Kaneshalingam.

POSITION OF VICE PATRONS

President asked the membership to support an amendment to the constitution. This amendment is to add five positions of vice patrons. The position is for a period of

five year period. This is similar to how Colombo and Canada branch operates. Mr Sri Anandarajah wanted the reasons for the proposals. Mr Elango said that the positions provide guidance and advice to the committee. He further explained that the Vice Patrons will be part of the committee but have no vote. The amendment was passed by the membership. Proposed by Mr. Sugumar and seconded by Mr Srianandaraja.

EXPANDING OBJECTIVES

President requested an amendment to expand the objectives in the constitution to provide humanitarian assistance to others and other institutions in Sri lanka. Mr Paheerathan said that expanding the objectives outside Hartley brings in difficulties in managing the branch. He suggested to leave the focus on Hartley only. Mr S. Srianandarajah also spoke saying that it is better to keep the focus towards Hartley. The president therefore dropped the proposal.

7.ANY OTHER BUISNESS

Mr. Sri Anandarajah Congratulated Mr. V. Sugumar for his excellent service and requested for big hand.

Mr. C. Paheerathan suggested an increase of the membership to \$25. But Mr Sriskandaraja explained that there was no notice. Therefore this proposal is moved for consideration for 2005 AGM.

Mr. James Sugumar then handed the chair to Mr Charls Somasundaram and congratulated the incoming committee. He said that he had an excellent relationship with the committee members and that will continue with Mr Somasundaram. Mr. Charles Somasundaram thanked the members for electing him as president. He pledged his full dedication to the branch to achieve many more goals.

As there were any more issues raised the president thanked all the members and declared the meeting close at 9-15pm.

Appreciations

MR. GAJENDRAN BALASINGHAM

A prominent Old Hartleyite, Mr. Gajendran Balasingham, passed away on sixteenth of July, this year, following a brief illness. His funeral took place three days later at the Kanatta cemetery, Colombo.

He leaves behind his wife Dr. Saraswathy and sons Kishan and Dharshan.

Gajendran joined Hartley as a student in 1958, soon after the communal disturbances. He lived at Manthikai with his maternal grandfather, the much revered Manickavasagar, the registrar and the Chairman of the Puloly Village Council. His classmates included P. Elango (Australia), my cousin S. Sabapathipillai (Canada), Santhiranantha Ratnarajah (Australia) and Jeyakumar Pooranampillai (Peradeniya, Sri Lanka), son of 'KP'. For his age, he was a tall and strongly built lad. In his class he looked more like a 'Giant' among ' Lilliputians'! The exception being Chandrapalan Arnold (Colombo), who was lean and tall.

He was my team-mate at cricket in 1959 and 1960. As a cricketer he was enormously talented. Gajendran was a lively person, who loved to narrate stories and also tease the fellow team-mates. At Hartley, he was a very popular person among the students. In 1962 he captained the Hartley College Cricket Team. The same year he was adjudged as the best School Cricketer of the North. He won the Ceylon Schools Best All-rounder Prize, the President's Cup and was appointed as the vice-captain of the Ceylon Schools Cricket Team that toured Australia.

After leaving Hartley he joined St. Thomas College, Mount Lavinia and excelled in cricket as a fast bowler. After leaving school he became a tea planter and thereafter went into tea brokering business. (*Contributed by N.Karunakaran*)

Dr Nadarasa Rajamanikkam

Dr Rajamanikkam passed away peacefully on the 13th of August 2004, in Sydney. He was born on 03 March 1921 and grew up in Viyaparimoolai, Point Pedro. Dr Rajamanikkam studied at Hartley College in 1930's and persued his medical training in Colombo Medical College in the early 1940's.

After completing his training he worked as a registered medical practitioner in Trincomalee, the Hill country, and Colombo. He returned to Point Pedro and continued in government service between 1971 and 1975. Dr Rajamanikkam then retired from government services and worked privately in his own practice "People Dispensary" in Point Pedro where he was popularly known to many of us. In 1992 he closed his dispensary due to the escalating civil unrest and moved to Trincomalee until his wife and he were reunited with their two daughters in Sydney in 1996.

Dr Rajamanikkam was well-known for his kindness, skillful medical care and humbleness. He is survived by his wife Mrs Balambikai Rajamanikkam, daughters Jamuna and Saroja and son Dr Anantharajah who is also an old Hartleyite.
